1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and GreenEyes Artificial Intelligence Services LLC., in the following GreenEyes.AI (“**Company**,” “**we**,” “**us**,” or “**our**”), concerning your access to and use of the <https://www.greeneyes.ai/> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”). We are registered in Delaware, United States of America and have our registered office at 16192 Coastal Highway, Lewes, 19958.
